

The program benefits eligible Pennsylvanians who are 65 years or older, widows and widowers 50 years or older, and those 18 years or older with disabilities. Income limits increased again this year to \$46,520 for both homeowners and renters. This is due to a 2023 law I supported that calls for adjusting the income limit based on annual increases in the Consumer Price Index. Remember to exclude 50% of Social Security when determining your income. The maximum rebate is \$1,000.

If your standard license plate is blistered, peeling or discolored, we will have the required paperwork to fill out. There is no fee for this service. Bring your vehicle and registration card with the affected plate, and an officer with the Titusville City Police Department will be available to help complete the application.

REAL ID Deadline Looming

The deadline for enforcement of the federal REAL ID Act is fast approaching.

As of May 7, you will have to present a federally accepted form of identification to board a commercial domestic flight or visit a secure federal building that requires ID at the door. Federally accepted forms of identification include a Pennsylvania REAL ID driver's license or ID card, a U.S. passport or passport card, or a military ID.

While all Pennsylvanians must comply with the new law, obtaining a state-issued REAL ID is not mandatory. PennDOT will continue to offer standard-issue driver's licenses and photo IDs.

Full enforcement of the law has been delayed several times due to the COVID-19 pandemic, which was hindering efforts to process REAL ID applications across the country.
